The undersigned hereinafter call "The Member", agrees to purchase water services from Tri County Water Association, Inc., hereinafter called "Corporation" upon the following terms:

1. Member agrees to comply with and be bound by the Corporation's By-Laws and Rules and Regulations, which by reference are made a part of this agreement. A copy of said By-Laws and Rules and Regulations are available at the Corporation's Business Office located at 228 East Prairie Road, Eagle Butte, South Dakota, 57625.
2. Member agrees to pay a hook up fee of **\$2000.00** (does not apply to existing services).
3. Member agrees to pay a temporary hook up fee of **\$2500.00** for temporary hook ups.
4. The member agrees to give a Grant to the Water System, such easement(s) as it shall require to provide water services to said member. Where the member is a non-land owner, this Agreement shall not become effective an binding upon the parties there to, unless an initial Right-Of-Way Easement has been executed with the land owner is made a party to this Agreement. The Easement(s) referred to in this Agreement and referenced in Covenant running with the land for the benefit of the Corporation, it's successors and assigns.
5. The members shall, as soon as water service is provided by Corporation, pay for said water service at such rate which shall be fixed by the Board of Director from time to time.
6. The members who do not own the Property being served, must deposit **\$100.00** with Tri-County Water Association, Inc. and an additional **\$75.00** reconnect fee will be assessed to residences in which water services have been disconnected. The **\$100.00** deposit is refundable upon termination of the water usage at that upon particular residence provided that the Meter Pit is not tampered with in any way and the bill is paid in full.
7. The member understands that he or she is responsible for the water services his or his address up until the time the water service is disconnected following the request to discontinue the service by the member. The responsibility to pay for said water services

continues even if the listed member to be billed moves out of the residence in spite of any personal contracts or agreements in which a third party agrees to be responsible for paying for the member's water services.

8. The member understands that the corporation shall not be liable for damage of any kind whatsoever resulting from water or the use of water on member's premises, and the corporation shall not be responsible for the payment of all water which flows through the member's meter.
